RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT BY SIGNING THIS AGREEMENT YOU, YOUR FAMILY AND REPRESENTATIVES WILL WAIVE CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE. PLEASE READ CAREFULLY!

Attn: Percy Ycomena, Green Wild Amazon Expedition (referred to hereinafter as the “Operator”) and all associated and affiliated companies and individuals as they now exist, or may hereafter be acquired (referred to hereinafter as the “Releasees”).

In consideration of the Operator accepting my application for and my being permitted to participate in this expedition involving travel with the Operator, I agree to this RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT (collectively referred to hereinafter as the “Agreement”).

For the purposes of this Agreement an “Expedition” shall extend from the time I am initially picked up in Iquitos, Peru by the Operator to my final departure from the Operator in Iquitos, Peru.

Safety Acknowledgement and Assumption of Risks

I am aware of the risks, dangers, and hazards associated with adventure travel in the Amazon Basin, and I freely accept and fully assume all such risks, dangers and hazards and the possibility of personal injury, death, property damage and loss resulting from such expeditions. I am aware and expect the unpredictable terrain, as well as the inherent risks associated with exploration within the Amazon Basin.

I further acknowledge and agree that while traveling I shall, at all times, follow the guide’s instructions. I understand that failure to do so may result in injury or possible loss of life to others or myself or may result in the suspension of my right to continue further on the expedition.

Insurance

I acknowledge that it is my responsibility/choice to arrange my own travel, medical, or accident insurances for this expedition/training course. I also understand that it is my responsibility to have secured any vaccinations relevant to where I will be travelling and to the duration of the travels. I understand that good health is needed in order to commence this expedition.

Release of Liability, Waiver of Claims and Indemnity Agreement

Upon admission by the Operator to allow my participation in an expedition or training course and by permitting my use, if applicable, of their resources, I hereby agree to the following:

- 1) On behalf of myself, my heirs, next of kin, executors, successors, administrators, assigns and whomever else may have an interest either by common law or operation of statute, I hereby waive any and all claims I or other such parties have or may have in the future against the Operator or Releasees, and I release from all liability and agree not to sue the Operator or Releasees for any and all personal injury, death, property damage, expense or loss sustained by me or my next of kin as a result of my participating in this expedition/training course with the Operator due to any cause whatsoever including, without limitation, negligence, breach of contract, or breach of any type on the part of the Releasees, and also including the failure on the part of the Releasees to safeguard or protect me from the risks, dangers and hazards of this adventure referred to above.
- 2) I hereby hold harmless and indemnify the Operator and Releasees from any and all liability for any damage to property, or personal injury to any third party, resulting from my use of equipment or participation in this expedition/training course, or travel beyond the designated areas.
- 3) This Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns, representatives and successors in the event of my death or incapacity, or in the event that I am the legal parent or guardian of the participant who is under the age of eighteen (18) years, it shall be effective and binding on his or her heirs, next of kin, executors, administrators, assigns, representatives, parents, guardians, or successors.
- 4) In entering into this Agreement I am not relying on any oral or written representations or statements made by any of the Releasees or Operator, including those in any brochures or on the internet, to induce me to go on an expedition or participate in a training course with the Operator, with respect to the safety of the activities other than what is set forth in this Agreement.
- 5) I further agree that the terms of this Agreement may only be amended by a duly executed written Agreement between the Operator and or Releasees and myself, and that this Agreement shall not be affected or altered by any subsequent oral or written representations made by any of the Releasees or Operator.
- 6) This Agreement and any rights, duties and obligations as between the parties to this Agreement shall be governed by and interpreted solely in accordance with the laws of Peru and by no other jurisdiction.
